The BeComingOne Church has a religious objection to forced vaccination, coerced vaccination, public and private vaccine mandates:

- (1) because some newer vaccines interfere with God the Creator's creation by manipulating the highly complex DNA / RNA / PROTEIN / BIOELECTRICITY¹ system;**
- (2) because the forced/coerced/mandated requirement to get vaccinated is a potential foundation of a coming Mark of the Beast;**
- (3) because the forced/coerced/mandated requirement to get vaccinated interferes with the freedom of religion and the freedom of choice of all humans (*aka*: "my body, my life").**

Vaccines for Covid-19 manipulate the work of the Creator in novel and concerning ways that may indicate playing God in the arena of fooling with the DNA/RNA codes written by the Creator. Both the adenovirus and the mRNA vaccines appear to do so:

"Like the mRNA vaccines, the main idea behind adenovirus vaccines is to get genetic material that encodes SARS-CoV-2 genes into your cells and get your cells to make the virus proteins. The difference is in how they do this. Where the mRNA vaccine is just the mRNA protected by a chemical shell, adenovirus vectored vaccines use a virus we know is harmless to act as a Trojan horse. But instead of hiding Greek soldiers, or anything dangerous, the adenovirus releases genes that encode the SARS-CoV-2 spike protein." "Currently, mRNA is considered a gene therapy product by the FDA. Unlike certain gene therapies that irreversibly alter cell DNA and could act as a source of side effects, mRNA-based medicines are designed to not irreversibly change cell DNA; however, side effects observed in gene therapy could negatively impact the perception of mRNA medicines despite the differences in mechanism." There are also DNA vaccines under development (https://en.wikipedia.org/wiki/DNA_vaccine). One of which was approved by the Indian government in August 2021. When you alter the DNA / RNA / Genes system you are changing the very code of life created by the Creator.

Besides this danger of playing God, vaccines or the manipulation of genetics should not be used to restrict the buying or selling of products or labor; nor should any vaccines be required to buy and sell (labor or products). The prophecies of the Bible's book of Revelation are connected with pharmaceuticals (drugs), the mark of the Beast, the number 666 and the ability and inability to buy or sell. "16 And it causes all, the small and the great, and the rich and the poor, and the free and the servants, that they should give them a mark upon their right hand or upon their forehead; 17 and that **no one should be able to buy or sell except he that had the mark**, the name of the beast, or the number of its name. 18 Here is wisdom. He that has understanding let him count the number of the beast: for it is a man's number; and its number is six hundred [and] sixty-six." (Rev 13:16-18, BCB)

The pharmaceutical connection. Literally, Rev 18:23, speaking about the “Great Babylon” (Rev 18:2) refers to the great merchant men of the earth misleading all the nations with their administering of drugs (Rev 18:23). Unfortunately, “administering of drugs” in the Greek has been mistranslated in English to “sorcery” which hides the true meaning of several verses in the Book of Revelation.

“and [the] light of lamp[s] shall shine no more at all in you, and [the] voice [of] bridegroom[s] and bride[s] shall be heard no more at all in you; for your merchants were the great ones of the earth; for by your **sorcery** have all the nations been deceived.” (Rev 18:23, BCB, emphasis added)

The word translated in Rev. 18:23 as **sorcery** is the Greek word:

φαρμακεία (pharmakeia) — Strong’s number 5331
Word Origin: from pharmakeuō (to **administer drugs**)
Definition: the use of medicine, drugs or spells
This literally means “drug-related sorcery”

Literally, the second part of Rev 18:23 reads: “for your merchants were great men [princes, nobles] of the earth; for by their **administering of drugs** were misled all the nations.”

“And the rest of men who were not killed with these plagues repented not of the works of their hands, that they should not worship demons, and the golden and silver and brazen and stone and wooden idols which can neither see nor hear nor walk. And they repented not of their murders, nor of their **witchcraft**, nor of their fornication, nor of their thefts.” (Rev 9:20-21, BCB, emphasis added)

The word we translate here as **witchcraft** is the Greek word:

φαρμάκων (pharmakōn) — Strong’s number 5331
Word Origin: from pharmakon (a pharmaceutical, a drug)
See [Appendix](#) below for Greek text and Lexicon translation.

Literally, the second part of Rev 9:21: “And they repented not of their murders, nor of their **pharmaceuticals** [drugs], nor of their fornication, nor of their thefts.”

As we just demonstrated, English translations of the book of Revelations mistranslate pharmaceuticals (drugs) as “sorceries” or “witchcraft” or magic. Parenthetically, many people today think of modern drugs as magical. The prophecies of the Bible’s book of Revelation is connected to pharmaceuticals (drugs), the mark of the Beast, the number 666 and the ability and inability to buy or sell.

It is important to consider that in accepting vaccine mandates, we believe we would be helping to establish the foundations of a relatively soon coming Mark of the Beast.

Great caution and skepticism should be used in relation to any use of pharmacy to restrict participation in the economy in any way during these times.

The vaccines themselves in general are using new technologies which delve into gene therapy. Our genes come from the Creator.

It is highly indicative of a foundation of a Mark of Beast system for vaccine mandates to be required to work and to prohibit the right of people to sell their labor or buy products unless they participate in the “sorcery” (“take this drug or else...”) demanded by the world’s governments. While it has been typical to ask for extensively tested vaccines developed with older technologies at certain borders or in some schoolchildren

to eliminate childhood diseases or particular travel-related issues (with exemptions), the way in which Covid-19 vaccines are being required, without regard to risk, with scant regard to safety or trials, with censorship and repression, without regard to the current lower risk of children, without regard to natural immunity, all speak to sinister or foolish motives we must regard with skepticism.

It is time to think that Covid-19 and other new plagues *may* be the result of sinful biological warfare programs which may indicate nefarious motives among governments.

Even if vaccines were to employ older technology, the requirement of them in order for a person to work or sell too closely indicate a foundation upon which a Mark of the Beast could be erected.

While prior vaccines like measles, rabies, and smallpox had different technology, with the smallpox vaccine going back to comparatively primitive times, newer vaccines are engaged in increasing levels of the “sorcery” referenced in the Bible, even manipulating genes, while simultaneously being used as qualifications to buy products and sell labor. The Code of Life is potentially being fooled and tampered with. **The Code of Life is highly complex, thus more likely is the chance that a vaccine will not work as intended and cause a catastrophic chain of events.**

Proper risk benefit analysis is not being sufficiently used. This is alarming. For example, children are at little risk currently but some entities, governments, schools, organizations are eager to begin to require vaccination in children, and this alarmingly appears to sacrifice potentially children’s future wellbeing for possible ulterior motives of adults connected to those in powerful positions in government and business. Is this the return of an ancient child-sacrifice system repackaged for modern times? If so this should set off alarm bells. Why should children’s future health be sacrificed for profit or power? The DNA, RNA and the Bioelectricity² system is nothing to be played with. Satan, not God, requests the sacrifice of children.

Product safety appears to us to be discounted. This is concerning and speaks of ulterior motives. We see these products treated differently than other medications, and this subject is heavily censored by media, governments and rulers. We see great pressure to ram vaccines through the approval process to get a needle in every arm, safety profile be damned, risk-benefit be damned, natural immunity be damned. Lies, half-truths and obfuscation abound on the safety profile of these products. And this is greatly alarming and causes questions as to the motive behind this worldwide movement. Concerns like antibody dependent enhancement and “leaky” vaccine driven variants are not given sufficient attention, care, or scrutiny in our opinion, raising the opportunity for actually creating great man-made plagues or death such as pointed to in Revelation 6:8.

We are not believers in crazy conspiracy theories and we are not against real science that is based on the scientific method, but we are deeply concerned with the irrationality – the madness – taking over the world. At the end of the world Satan drives the world mad and to self-destruction. (See [PR6](#)) When a world closes down their economies for Covid-19 that has only caused about 1-10 percent more yearly deaths (excessive deaths — about 1-5 million) in the world than what was expected (about 59 million), then you know something is wrong and delusional about the world’s thinking.³ Wouldn’t a real dangerous pandemic kill at least 5-10% of the world’s total population (376-750 million), not just 5 million? Another aspect is that a study of 540,667 Covid-19 patients between March 2020 and March 2021, “94.9% had at least 1 underlying medical condition” including hypertension, lipid metabolism, obesity, diabetes, etc. Some had up to 10

conditions.⁴ So did Covid-19 cause their deaths, or did the underlying conditions cause the deaths attributed to the virus? Maybe Covid-19 was just slightly worse than a yearly flu outbreak? Why the panic? Why the fear? Why destroy the economy? Why take away the people's freedoms for a virus outbreak that was only like a bad flu year?

The urgency with which these mandates are established, and the lack of proper risk benefit analysis, the eschewing of therapeutic treatments, the discounting of testing efforts and natural immunity speak to either sinister motives or great foolishness of those in power.

We fear all of the above is the groundwork laid to usher in the reign of the System of the Beast.

Periodic testing normally does not require taking medicines so it may not be equal to the English Bible's "sorcery" (administering of drugs) called out in Revelation, except if the "testing" is invasive (testing methods that *insert gene altering substances* into the the body). At this time, a Mark of the Beast has not yet been put in place (although the foundations appear to be materializing).

The BeComingOne Church supports the sincerely held beliefs of any of its members to refuse **vaccine mandates** based on religious grounds because we believe that these mandates will be used as a foundation to usher in the Mark of the Beast.

The BeComingOne Church supports the sincerely held beliefs of any of its members to refuse **even traditional vaccines if they are being coerced to take them** from this point forward based on religious grounds since such coercion may be used as a precedent to usher in the Mark of the Beast.

The BeComingOne Church supports the sincerely held beliefs of any of its members to **refuse vaccines based on religious grounds that use gene therapy** to alter the Creator's work.

Our members should not be barred from buying or selling products or their labor based on their sincerely held beliefs. This is a matter of religious freedom and freedom of conscience. In the United States, this is protected by the First Amendment to the United States Constitution.

Religious freedom has numerous other protections in various countries' laws and in international law.

Our belief in this matter is irrespective of any agency (or person) belonging to any nation or international group "approving" any DNA / RNA / or gene-manipulative vaccines or procedures or drugs.
